### Ocean Drive update on paving project

### Signage at gates "no RV's or Campers"

### Effectiveness of no parking on streets

Wind and winter storms have destroyed most of the grass that had been planted All agreed to wait until spring after planting to put up the signage.

# Work on perimeter fence by quads and fence repairs

### Scott Culp report replacing broken & missing street signage

Scott reported a number of broken and missing street signs in addition to a few areas of fence needing repair.

Bros & Hoes replaced the wrong fencing but agreed to replace the correct section gratus.

Scott asked if the Board wants to keep Michael C "on retainer". Michael is licensed and bonded, and lives in KS. The Board voted and approved contracting with Mike instead of B&H. A few of the road signs need

to be replaced in addition to the fence repairs. There will also be trimming and power washing of the bridge needed in the spring.

The Board also agreed to have Scott review all issues shared, present a cost estimate, and have Mike do the work.

Per Paul Boyle, he and Michael C walked the perimeter to determine fences/posts that need to be repaired.

Repairs to include addition of a third rail on the fence bordering 4 Sisters to discourage people from climbing over the fence.

#### Tierra Del Mar & Facebook

Facebook says they've been working with the community and county, state and federal officials since Fall 2018 to land fiber optic cable in Tierra Del Mar.

Coastal residents want to stop what they say amounts to a fracking project under a pristine beach.

Paul Schmidt thought everyone should be aware of this issue.

Signs have been posted in Tierra Del Mar voicing the community's attempts to stop the project.

## Review of 2019 financial statements and approval of 2020 proposed budget

The Board unanimously approved the 2019 year-end financials.

No delinquencies over \$500, but a few special assessments have not yet been paid. Paul suggested we see if dues paid in the spring will also include outstanding special assessments. If not he will refer to the attorney so they can send a letter. The Board agreed unanimously with this approach.

No sand removal was needed this year.

Adopted 2020 proposed budget.
